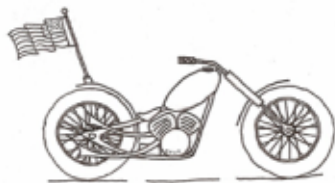
#### **RAFFLES**

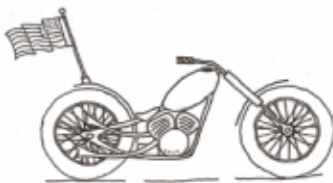

I ACKNOWLEDGE THAT PARTICIPATION IN THIS EVENT IS VERY DANGEROUS AND INVOLVES THE RISK OF SERIOUS INJURY AND/OR DEATH OR PROPERTY DAMAGE.** I absolve, release, waive, discharge and **AGREE NOT TO SUE** Qwest, its affiliates, all sponsors, organizers and associated entities/individuals and each of them, their directors, officers, employees, members, and agents (all referred to herein as "releasees"), from any and all blame for any injury, harm, loss, or inconvenience suffered, any liability to me, my personal representatives, heirs and next of kin, related to or arising out of this event, for injury to me, my family, including minor children, participating in the event, my property (both family and property referred to herein as "mine"), or resulting in my death or the death of a family member, whether caused by negligence of Qwest or other releasees or otherwise.
